The Criteria for recruitment of Consultants and Real Life Resource Persons

Persons wishing to be engaged as **Consultants** should meet the following criteria:

- Minimum level of education- A degree in social sciences.
- A minimum of three years working experience in the field of alcohol and drug abuse.
- Must be a resident in one of the following provinces Coast, Eastern, Central, North Eastern, Rift Valley, Nyanza and Western.
- Experience in working as a Trainer of Trainers (TOT) will be an added advantage.

Persons wishing to be engaged as **Real Life Resource Persons** should meet the following criteria:

- Minimum level of education- A diploma in addiction counseling or a related field.
- A minimum of two years in recovery/ sobriety(Attach a supervisor's recommendation)
- A minimum of one year working experience in the field of alcohol and drug abuse.
- Must be a resident in one of the following provinces Coast, Eastern, Central, North Eastern, Rift Valley, Nyanza and Western.
- Experience in working as a Trainer of Trainers (TOT) will be an added advantage.
- Applications should include a Real Life Story of the experience with substance use (a maximum of 2 pages)
